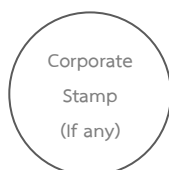

**Attachment : Service Application Process for Subscribers (New Subscription)**

- 1. Application Submission:** Complete the application form and submit it to ThaiBMA.
- 2. Contract Drafting:** ThaiBMA will draft the service agreement and return it to the applicant.
- 3. Contract Finalization and Service Commencement Date:** The agreement will be revised until both parties reach a mutual understanding and agreement. The service commencement date will then be set, and the final version of the contract will be prepared. The contract must be fully signed by both parties.

(a) If the applicant can specify the expected payment date, the service commencement date can be determined accordingly.

(b) Typically, ThaiBMA has a payment period of 30 days. The service commencement date may be set after the payment due date.

**Please note:** Although a service commencement date may be set in the contract, the service applicant must ensure that payment is received by ThaiBMA before the service can begin. This policy also applies to API services that include a contractual testing period, as ThaiBMA must receive payment before the test period can commence.

- 4. Invoice Issuance and Payment:** ThaiBMA will issue an invoice for the service fees. The policy requires the applicant to make a full payment before the contract can be finalized and services can commence.

(a) The applicant is responsible for paying the exact invoiced amount and for covering any associated transaction fees.
